The Ghodaghodi Municipality has allocated funds towards the cost of the construction of **Ghodaghodi Bahumukhi Campus Chhatra Awash** and intends to apply part of the funds to cover eligible payments under the Contract for **NCB/GMUN/WORK/24/079/080**Bidding is open to all eligible as per Section V of bidding document.

- 1. *Ghodaghodi Municipality* invites electronic bids from eligible bidders for the construction of NCB/GMUN/WORK/24/079/080 under National Competitive Bidding Single Stage Single Envelope Bidding procedures.
- 2. Under the Single Stage, Single Envelope Procedure, Bidders are required to submit simultaneously one s sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- 4. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a>. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below (no hard copy).

- 5. Pre-bid meeting shall be held on 2022/10/13(12:00)
- 6. Electronic bids must be submitted to the office *of Ghodaghodi Municipality*, *Sukhad*, *Kailali*through PPMO's e-GP system <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a>on or before *12:00 hours* on *14/07/2079* (*31/10/2022*). Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on 14/07/2079 (31/10/2022). at the office of Ghodaghodi Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of



- the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs. **1,91,000.00**, which shall be valid for 30 days beyond the validity period of the bid
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. The **Employer** reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
- 10. In the case of discrepancies or error in bid documents, bid notice or any other documents, **Ghodaghodi Municipality** reserves the right to amend the correct at any time. The figure for the bid amount must be clear if any discrepancies may occur then the figure written in word is valid.
- 11. **Ghodaghodi Municipality** office will not be responsible for any costs or expense incurred by bidders for preparation or delivery of bids. Except the mentioned clauses all other condition of the bidding process must be followed by the Public Procurement Act 2063, Public Procurement Regulation 2064.
- 12. Bids should comply in all respects with the instruction to bidder included in the bid document. Non-Compliance with this instruction shall result in disqualification.
- 13. Bidders are advised to visit the construction site and access the actual site conditions before submitting their bids.
